It is known from the Jataka Stories that Shresthiputra and Prince pay full fees in Takshashila but there was complete education system for poor children too. It was the duty of the state and society to make proper arrangements for the livelihood of the scholars. The rulers and nobles donate land and money etc for this purpose. The great Indian scholars and rulers like Panini, Kautilya,, Jivaka, Kaushalraj, Prasenjit educated at Takshashila. There are many references where village, property, food donation done by such affluent classes to educational institutions. Agrahara Grama were donated to Brahmin scholars during the

Generations of the Gupta rulers had donated the income of many villages for better education System of Nalanda. During the period of Pal rulers Vikramshila was an educational institution where education was given under social responsibility. The role of social responsibility of universities in India has existed since ancient time.

USR and Holistic Approach of Education

The concept of USR was developed by a group of Chilean university through the project "University build country" between 2001 and 2005ⁱ. Madhya Pradesh Education Minister suggested that all universities and colleges to adopt villages and work in them under social responsibility. 
